Subject:-Matter related to submission of fixed security deposit for issuance of letter of permission (LOP) to The Managing Director, Bhai kanhaiya Sewa Society, Hanumangarh Road, Near Bye-pass, Opposite BSF Campus, Abohar - 152116, Punjab to establish a new Ayurvedic Medical college in the name of Punjab Institute of Ayurved, Hanumangarh Road, Near Bye-pass Opposite BSF Campus, Abohar- 152116, Punjab (AYU0840) with 48 seats (instead of 60 seats) in UG (BAMS) course under section 29 of the NCISM Act, 2020 from the academic session 2023-24-reg.

Sir,

With reference to the subject mentioned above, I am directed to inform you that, in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021 and With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 has been dissolved and as per section 59(2) of the National Commission for Indian System of Medicine Act, 2020 it is stated that, "Notwithstanding the repeal of the Indian Medicine Central Council Act, 1970, the Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under:", The provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

Further vide Medical Assessment and Rating Board for Indian System of Medicine letter of **even number dated 31.10.2023 Letter of Intent** was issued to your trust **to establish a new Ayurvedic Medical college in the name of Punjab Institute of Ayurved, Hanumangarh Road, Near Bye-pass Opposite BSF Campus, Abohar- 152116, Punjab (AYU0840) with 60 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 from the academic session 2023-24.**

The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) has carried out an inspection of the institution again on **22.11.2023 and 23.11.2023** for issuance of **Letter of Permission (LOP)**. On examining the assessment report certain deficiencies were observed and an opportunity of hearing was granted to your college on **28.11.2023**.

The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report once again examined and it is found that your trust is fulfilling the eligibility criteria for issuance of **Letter of permission (LoP)** to establish new Ayurvedic medical college in the name of **Punjab Institute of Ayurved, Hanumangarh Road, Near Bye-pass Opposite BSF Campus, Abohar- 152116, Punjab (AYU0840) with 48 seats (instead of 60 seats) in UG (BAMS) course under section 29 of NCISM Act 2020 from the academic session 2023-24 due to deficiency of two teacher against the requirement of 06 teachers for conditional permission as per MSR.**

Therefore, as per NCISM Act 2020 and sub-regulation **6 (1) (i) (i)** of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, you are requested to remit the amount of **Rs. 01 Crore (One Crore)** by way of a demand draft or online payment payable to **"The National Commission Fund for Indian System of Medicine** as fixed security deposit for a period of five years to establish new Ayurvedic Medical college **with 48 seats (instead of 60 seats) in UG (BAMS) course from the academic session 2023-24, Under section 29 of NCISM Act 2020 and relevant regulations there under.**
